I want to go carefully over ^{the} Goodwillie, Feigin, Tsygan result on the cyclic complex of a semi-direct product $R \oplus M$. This complex is \mathbb{Z} -graded ~~by the degree~~ in ~~M~~ M . Thus for $p > 0$

$$(1) \quad CC_{q-1}(R \oplus M)(p) = ((R \oplus M)^{\otimes q} / (1-t))(p)$$

$$= \left\{ \bigoplus_{i_0 + \dots + i_p = q} R^{\otimes i_0} \otimes M \otimes \dots \otimes M \otimes R^{\otimes i_p} \right\} / (1-t)$$

The result states that $\sum CC_x(R \oplus M)(p)$ is isomorphic to $(M[1] \otimes_R B(R) \otimes_R)_\sigma^p$. Now in degree q we

have

$$(2) \quad (M[1] \otimes_R B(R) \otimes_R)_\sigma^p = \bigoplus_{i_1 + \dots + i_p = q} M \otimes R^{\otimes i_1} \otimes \dots \otimes M \otimes R^{\otimes i_p}$$

Let us now define a map Φ from (2) to (1) in the obvious way, namely by ~~identifying~~ identifying ~~(2)~~ (2) with the part of the direct sum in braces in (1) with $i_0 = 0$. Let's check that Φ is a map of complexes. Take $p=2$ and consider $[m, x_1, \dots, x_{i_1}, m_2, x_{i_1+1}, \dots, x_{i_1+i_2}, n]$ in (2).

Recall that the differential in $B(R)$ is an alternating sum of "face" operators each of which deletes a \otimes sign. Thus in $M \otimes_R B(R) \otimes_R N$ the differential is

$$d[m, x_1, \dots, x_p, n] = [m, x_1, x_2, \dots, x_p] + \sum_{i=1}^{p-1} (-1)^i [m, \dots, x_i, x_{i+1}, \dots, n] + (-1)^p [m, x_1, \dots, x_{p-1}, x_p, n]$$

In $(M[1] \otimes_R B(R) \otimes_R)^p$ there will be extra signs due to the suspension of M occurring. Thus

 &\quad + \sum_{j=1}^{i_2-1} (-1)^{2+i_1+j} [\dots, x_{i_1+j}, x_{i_1+j+1}, \dots] \\

~~How does this compare with the differential in the cyclic complex (1)?~~ In this formula we are assuming that $i_1, i_2 > 0$. How does this compare with the differential in the cyclic complex (1)? The sign of a face operator is the ~~parity~~ parity of the number of preceding faces. It's off by 1 from the number of elements preceding the comma. This also apply to the crossover term. Thus we conclude that Φ anti-commutes with d meaning that it is a map of complexes from the suspension of the cyclic complex.

Still should check what happens if either i_1, i_2 is zero.

Recall that we have a map ~~to~~

$$\Phi: \left(M \overset{[1]}{\otimes}_R B(R) \otimes_R \right)^{\mathbb{P}} \longrightarrow \left\{ \Sigma CC_x(R \otimes M) \right\}(\rho)$$

and we are trying to check that it is a map of complexes. What is the differential on the left? $M \overset{[1]}{\otimes}_R B(R)$ is a resolution of $M[1]$ by R -bimodules which are right free. One has

$$\left(M \overset{[1]}{\otimes}_R B(R) \right)_{n+1} = M \otimes_R (R \otimes R^{\otimes n} \otimes R) = M \otimes R^{\otimes n} \otimes R$$

and

$$\begin{aligned} d[m_1, x_1, \dots, x_n, x_{n+1}] &= d^{=0} m \otimes_R [1, x_1, \dots, x_{n+1}] \\ &\quad - m \otimes_R d[1, x_1, \dots, x_{n+1}] \\ &= -m \otimes_R \left\{ [x_1, \dots, x_{n+1}] + \sum_{i=1}^n (-1)^i [1, \dots, x_i x_{i+1}, \dots] \right\} \\ &= -[m \otimes x_1, \dots, x_{n+1}] + \sum_{i=1}^n (-1)^i [m, \dots, x_i x_{i+1}, \dots] \end{aligned}$$

Thus if we take an element of $\left(M \overset{[1]}{\otimes}_R B(R) \otimes_R \right)^2$ say $[m_1, x_1, \dots, x_k, m_2, y_1, \dots, y_\ell]$ its differential is

Thus d agrees with b on the suspension.

So it's clear that Φ is a map of complexes. The next thing to be checked is the action of \mathbb{Z}/p . What we must check is that (case $p=2$)

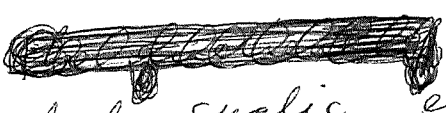
These are ^{related by} the flip in $(M \otimes_R B(R)) \otimes_R (M \otimes_R B(R)) \otimes_R$

$$(-1)^{(k+1)(l+1)} [m_2, y_1, \dots, y_l, m_1, x_1, \dots, x_k]$$

have the same image in $CC_{n-1}(R \oplus M)(2)$ where $n = k+l+2$. But this is clear, because τ is the cyclic permutation of degree n with the sign obtained by regarding the elements of $R \oplus M$ as odd.

At this point we are certain of the Goodwillie-Feigin-Tsygan isomorphism for $R \oplus M$. How do we see that Φ induced an isomorphism on the quotient by σ ?

We can describe $\textcircled{\otimes} CC_{n-1}(R \oplus M)(p)$ as



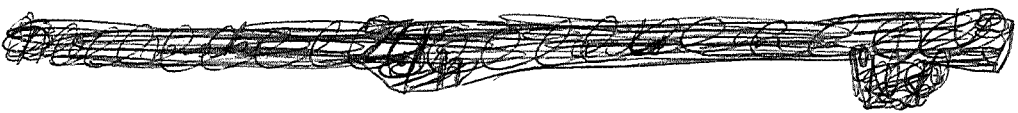
follows. Let S be the

set of cyclic embeddings of $[p]$ into $[n]$, where $[p] = \{1, \dots, p\}$. Another way of describing an element of S is to give a card p subset with basepoint in $[n]$.

S is acted on by $\mathbb{Z}/p \times \mathbb{Z}/n$ and the quotient by the action of \mathbb{Z}/p is the set of card p subsets of $[n]$. Given $s \in S$, let

$$V_s = R^{\otimes c_0} \otimes M \otimes \dots \otimes M \otimes R^{\otimes c_p}$$

if the image of $s: [p] \rightarrow [n]$ consists of the points $l_0+1, l_0+l_1+2, \dots, l_0+c_1+\dots+c_{p-1}+p-1$



?

The naive way to prove Φ is an isomorphism after dividing by \mathbb{Z}/p would be to show it's surjective + injective.

But Goodwillie's way is to show both sides are the \mathbb{Z}/p quotient of the same thing. To each cyclic embedding $s: [p] \rightarrow [n]$ we assign the tensor product

$$V_s = \bigotimes_{i=1}^n \begin{cases} R & \text{if } i \notin \text{Im } s \\ M & \text{if } i \in \text{Im } s \end{cases}$$

Alternatively

$$V_s = V_{s,1} \otimes V_{s,2} \otimes \dots \otimes V_{s,n}$$

where
$$V_{s,i} = \begin{cases} R & i \notin \text{Im } s \\ M & i \in \text{Im } s \end{cases}$$

~~Then we show that the tensor product~~ This depends only on the image of s , so perhaps I will write V_I for $I \subset [n]$.

In general one has

$$(R \oplus M)^{\otimes n} = \bigoplus_{I \subset [n]} V_I$$

and one has the cyclic skew-symmetric action of \mathbb{Z}/n . We have

$$\mathbb{C}_{n-1}(R \oplus M)(p) = \left(\bigoplus_{\substack{I \subset [n] \\ \text{card } I = p}} V_I \right) \mathbb{Z}/n$$

$$\left(\bigoplus_{\substack{s: [p] \rightarrow [n] \\ \text{cyclic}}} V_{\text{Im}(s)} \right) \mathbb{Z}/p \times \mathbb{Z}/n$$

and

$$\left(\begin{array}{c} \bigoplus \\ s: [p] \hookrightarrow [n] \\ \text{cyclic} \end{array} \quad V_{\text{Im}(s)} \right) \mathbb{Z}/n = \bigoplus_{\ell_1 + \dots + \ell_p = n} M \otimes R^{\otimes \ell_1} \otimes \dots \otimes M \otimes R^{\otimes \ell_p}$$

so we find that

$$CC_{n-1}(R \oplus M)(p) \cong \left\{ \left(M \otimes_R B(R) \otimes_R \right)_n^p \right\} \mathbb{Z}/p$$

There are some intriguing things going on here. Basically I have the feeling that I have to do things like parallel transport, + time-ordered exponentials, but where instead of having functions (or fields) along the curve, I have modules. Thus tensor product of modules occurs instead of composition (or product) of operators.

Next I should see what happens with the signs when I the superalgebra $R \oplus I$ where $I = M$ but considered as having odd degree. The first difference is that in

~~$$(R \oplus M)^{\otimes n} = \bigoplus_{J \subset [n]} V_J$$~~

$$(R \oplus I)^{\otimes n} = \bigoplus_{J \subset [n]} V_J$$

the action of \mathbb{Z}/n is different. Here

$$V_J = \bigotimes_{i=1}^n \begin{cases} R & i \notin J \\ I & i \in J \end{cases}$$

and in determining the signs only the R factors are considered odd.

The idea now will be to try to ⁴⁷⁶ get a map Φ from $(\mathbb{I} \otimes_R \mathcal{B}(R) \otimes_R)^p$ to a suitable shift of $\mathbb{C}C_{*}(R \oplus \mathbb{I})(p)$. NO

In order to handle the case of the DGA $R \leftarrow \mathbb{I}$ we have to be careful about the signs. What exactly does one mean by the cyclic complex of a DGA?

In general we obtain the Hochschild complex of an algebra A by taking tensor powers $A^{\otimes n}$ in degree $n-1$ and defining the boundary b to be the ^{alternating} sum of face operators.

$$b[a_1 | \dots | a_n] = \sum_{i=1}^{n-1} (-1)^{i-1} [\dots | a_i a_{i+1} | \dots] + (-1)^{n-1} [a_n a_1 | \dots]$$

The face operators are given by ~~the~~ the multiplication map $A \otimes A \rightarrow A$ applied to consecutive factors. The cross-over term is obtained by the flip isom.

$$(*) \quad (A^{\otimes(n-1)}) \otimes A \simeq A \otimes (A^{\otimes(n-1)})$$

followed by multiplying the initial two factors.

Now take A to be a DGA. ~~Then~~ Then each tensor power $A^{\otimes n}$ is a complex, and the face operators are maps of complexes since the multiplication $A \otimes A \rightarrow A$ is. Thus the Hochschild complex and the cyclic complex are complexes in the category of complexes, i.e. double complexes. (Thus the vertical + horizontal differentials commute and a sign must be introduced to define the total differential.)

Because the flip isomorphism \otimes used for complexes is not the same as for vector spaces, the crossover term for the DGA setup (really I should say superalgebra setup) is not the same as for the underlying ~~algebra~~ algebra.

For example, let's consider $A = R \leftarrow I$.

~~There is~~ The cross-over term involves the flip of the last factor to the front together with the sign $(-1)^{n-1}$. If the last factor is R , i.e. $n_p < n$, then there is no other sign, but if the last factor is I then we have the additional sign $(-1)^{p-1}$ because we have moved I past $(p-1)$ other factors I . Note that after performing the flip we multiply, so if both first and last factors are I the crossover term gives zero.

Now we can define

$$\Phi : (I \oplus I \otimes_R B(R) \otimes_R R)^p \longrightarrow \Sigma CC_{n-1}(R \oplus I)(p)$$

exactly as before. The calculation that Φ is a map of complexes is exactly the same except for the cross over term. We have defined Φ by mapping into the Hochschild group $(**)$, actually into the part where the first factor is I (always $n_1 = 1$), and then projecting into the cyclic complex. The ~~strange~~ strange signs appear in the cross over term only when the last factor is I . However as the first

factor is always \mathbb{I} this means the crossover term has to be zero, and so the strange signs have no effect. Thus Φ is a map of complexes.

The next step is to show that Φ commutes with the skew-symmetric cyclic action on the left (i.e. on its source). Take $p=2$ and consider the elements

$$[m_1 | x_1 | \dots | x_k | m_2 | y_1 | \dots | y_l] \in \left(\mathbb{I}[\mathbb{I}] \otimes_R B(R) \otimes_R \right)^2$$

and

$$(-1)^{\binom{k+1}{2} + \binom{l+1}{2}} [m_2 | y_1 | \dots | y_l | m_1 | x_1 | \dots | x_k].$$

This are related by the generator of $\mathbb{Z}/2$. When we apply Φ we obtain elements in $(R \leftarrow \mathbb{I})^{\otimes (k+l+2)}(2)$ which are denoted in the same way. The effect of $\mathbb{Z}/n\mathbb{Z}$ where $n=k+l+2$ introduces the sign

$$\begin{aligned} (-1)^{\binom{n-1}{2} + \binom{l+1}{2}} &= (-1)^{\binom{k+l+1}{2} + \binom{l+1}{2}} \\ &\equiv k(l+1) + (l+1) \pmod{2} \\ &= (k+1)(l+1) \end{aligned}$$

moving m_2 past m_1

showing that the Φ is consistent with the skew cyclic action. In the general case given

$$[m_1 \dots m_2 \dots m_p \dots] \in \left(\mathbb{I}[\mathbb{I}] \otimes_R B(R) \otimes_R \right)^p$$

in order to move m_p around in front we acquire a normal sign $(-1)^{\mu\nu} (= (-1)^{(n-1)\nu})$ since $(n-1)\nu = (\mu+\nu-1)\nu \equiv \mu\nu \pmod{2}$

The same sign occurs in $(R \leftarrow \mathbb{I})^{\otimes n}(p)$ with an additional sign of $(-1)^{p-1}$ when one moves m_p around. Thus Φ is compatible with $(-1)^{p-1} \sigma = \tau_p$.

R unital algebra, consider the bifunctor $K \otimes_R L$, where K, L are complexes of R -modules (~~right~~ right and left respectively), with values in complexes. Assuming L_n flat for all n , does it follow that $? \otimes_R L$ preserves quasi-isomorphisms? It suffices by the mapping cone construction to show that $H_*(K) = 0 \implies H_*(K \otimes_R L) = 0$. If then K is ~~exact~~ exact and L is flat, the double complex $K \otimes_R L$ has exact rows. One can't conclude the total complex $K \otimes_R L$ is exact unless L is bounded below or K is bounded above. In the former case we can express L as the union of bounded flat complexes $L_{\leq n}$, and in the latter we can express K as the union of finite exact complexes:

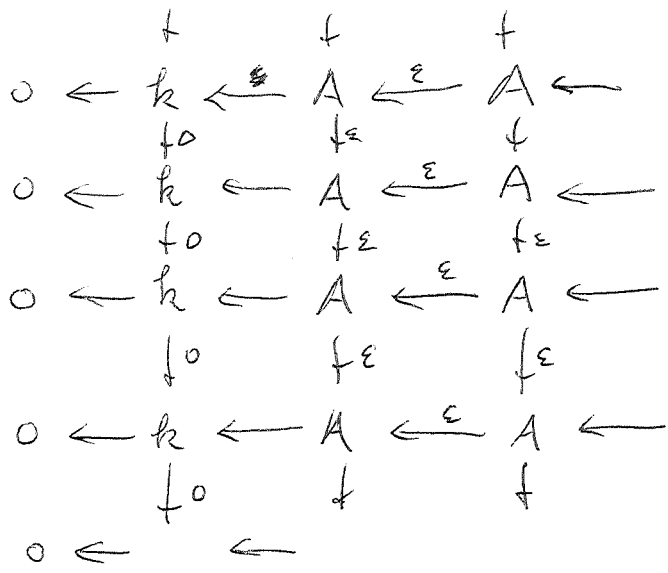

Then $K \otimes_A L$ is the double complex



This double complex is the union of the subcomplexes consisting of the first $p+1$ columns for different p . Since the p^{th} column for $p > 0$ is exact, it follows the cohomology of the double complex is that of the 0th column, i.e. k in each degree. Thus $K \otimes_A L$ is not exact. QED.

Let $R/I = A$ with $R = T(V)$ to fix the ideas. We consider the semi-direct product $R \oplus \Omega_R^1$ which can be viewed as an extension of A with the ideal $J = I \oplus \Omega_R^1$. Then

$$J^{n+1} = I^{n+1} \oplus \sum_{k=0}^n I^k \Omega_R^1 I^{n-k}$$

because $(\Omega_R^1)^2 = 0$. (More precisely any product $I^{l_0} \Omega_R^1 I^{l_1} \Omega_R^1 \dots$ lies in $\Omega_R^1 \cdot \Omega_R^1 \dots = 0$.)

~~...~~ We have two homomorphisms ~~...~~

$$R \implies R \oplus \Omega_R^1 \quad \begin{array}{l} x \mapsto x \\ \mapsto x + dx \end{array}$$

~~...~~ are homomorphisms "over" A , hence carry I to J . Thus we get two homomorphisms ~~...~~.

$$R/I^{n+1} \implies R \oplus \Omega_R^1 / J^{n+1} = R/I^{n+1} \oplus \Omega_R^1 / \sum_{k=0}^n I^k \Omega_R^1 I^{n-k}$$

of nilpotent extensions of A of order $n+1$.

These induce maps

$$HC_0(R/I^{n+1}) \implies HC_0(R/I^{n+1} \oplus \Omega_R^1 / \dots)$$

which agree on the image of $HC_{2n}(A)$. The latter group is the direct sum of $HC_0(R/I^{n+1})$ and

However $I^k \Omega_R^1 I^{n-k} \equiv I^n \Omega_R^1 \pmod{[R, \Omega_R^1]}$, so the last group is

Thus we have proved

Our goal will be ~~to~~ to show the kernel of u coincides with that of $(*)$. Once this done we ~~see~~ see that $HC_{2n}(A)$ is the ~~subspace~~ subspace of $HC_0(R/I^{n+1})$ equalized by two maps from R/I^{n+1} to another order $(n+1)$ nilpotent extension of A . Thus we will have

$$HC_{2n}(A) = \varprojlim_{R \rightarrow A} HC_0(R/I^{n+1})$$

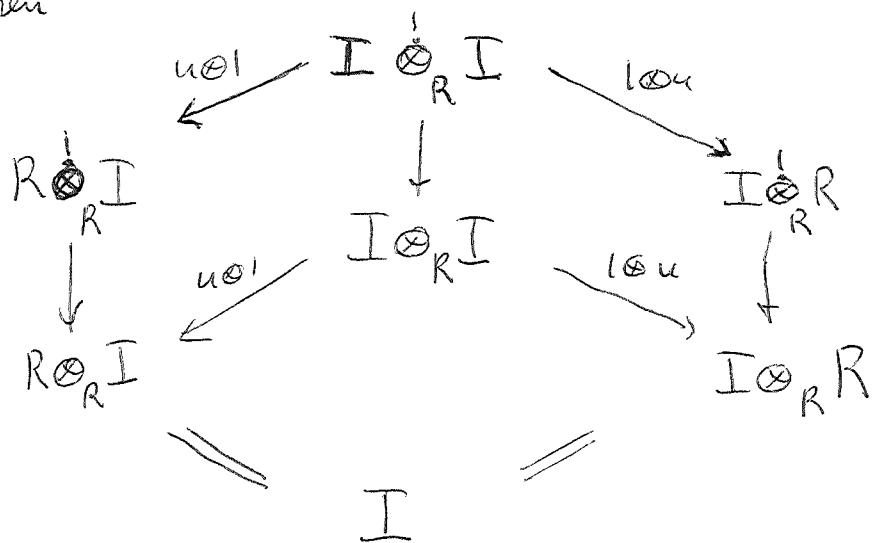

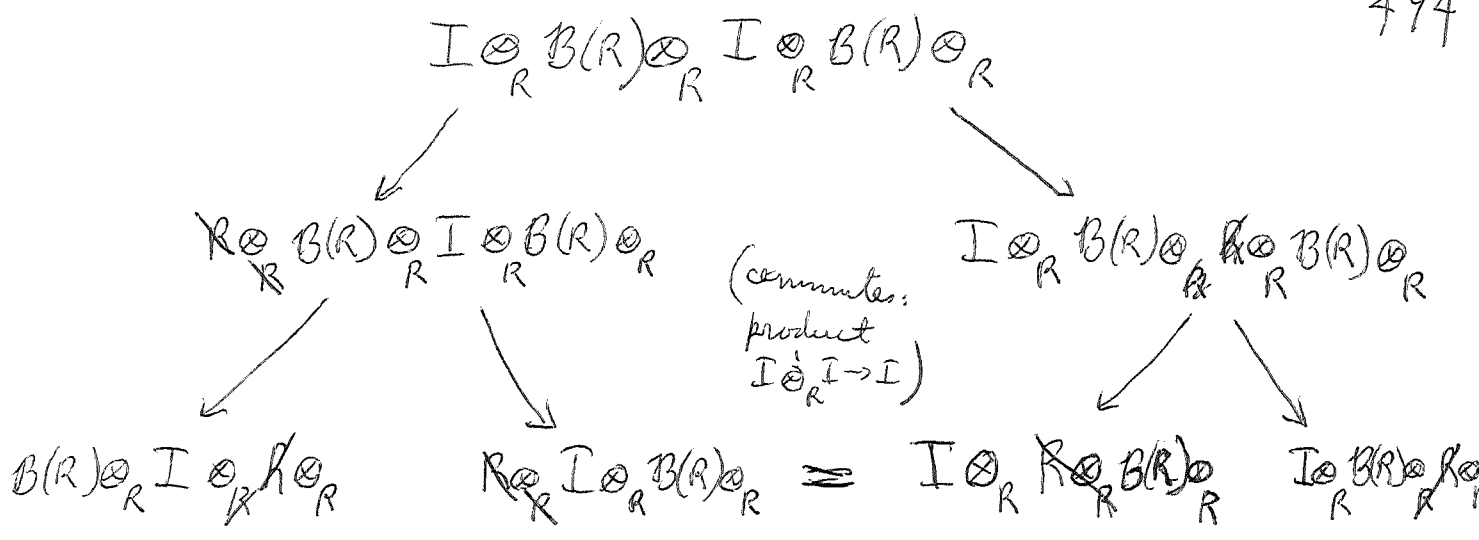

Then ~~(*)~~ there are two faces outside the degenerate complex and these have opposite signs. Next suppose the 1 occurs ~~(*)~~ at the left end:

and the reduced relative cyclic complex of $A(R)$ rel R . There's a shift by one both horizontally and vertically, which probably could be avoided if one reindexed the cyclic complex so that CC_n is the quotient of $(A \otimes)^n$.

At this point I probably have some understanding of the horizontal differential in $\mathbb{C}(R \leftarrow R)$, however I don't see how to put the ideal I into the picture. There doesn't seem to be anyway to make an ideal in $\mathcal{A}(R)$ which would be simple enough to handle.

The problem is to understand the horizontal differential

in the spectral sequences. We can lift back to a map

It's reasonable to expect that $h_i \partial_j$ commute (up to some shifts) provided i and j are not too close. So there might be a problem when the two indices are nearly equal. Let's take $I=R$ and look at the possibilities.

Wodzicki's spectral sequence. Let I be an ideal in R non-unital. Then the filtration $R \supset I \supset 0$ of R as a vector space induces a filtration on the tensor powers $R^{\otimes n}$ and on their cyclic quotients.



Next consider what the b -operator does to a symbol (x_0, \dots, x_n) having $\geq k$ elements in I . If two consecutive elements, say x_i, x_{i+1} , both are in I , then the symbol $(x_0, \dots, x_i x_{i+1}, \dots, x_n)$ has $k-1$ elements in I . ~~Therefore~~ Better, consider the face symbol $(\cdot, x_i x_{i+1}, \dots)$ in the formula for b ; this is to be understood as the cross-over $(x_n x_0, \dots)$ when $i=n$. If ~~both~~ both x_i, x_{i+1} are in the ideal I , then this face has $\geq k-1$ elements in I , and if at most one of x_i, x_{i+1} is in I , then the face has $\geq k$ elements. Thus we see the b operator relative to the filtration acts so as to decrease the number of I factors ~~by at most by 1~~ at most by 1, as indicated by the dotted arrows above.

When we pass to the associated graded complex, we obtain in degree $n-1$, the vector space

Let's consider non-unital rings. First let's look at the reduced cyclic complex of $R \leftarrow I$, where R is unital^{and $\neq 0$} . This is a double complex $\bar{C}(R \leftarrow I)$ with

$$\bar{C}_0(R \leftarrow I) = \bar{C}_\lambda(\bar{R} \leftarrow I) \otimes_{\bar{B}} B^{(1)}$$

and it seems that the p -th column for $p \geq 1$ is

$$\Sigma^{p-1} \left(I \otimes_R B^N(R) \otimes_R \right)_\sigma^p$$

where B^N is the normalized bar resolution, i.e.

and the p -th column is for $p \geq 1$

Notice that this doesn't for $p=1$ give the Hochschild homology. For $p=1$ in degree n it is

Morita equivalence: Why are ~~these~~ Hochschild and cyclic homology Morita invariant?

You have a derived category viewpoint for ~~the~~ Hochschild homology. Is it possible to prove Morita invariance of Hochschild homology by derived functor methods?

What is a Morita equivalence? Suppose we have two algebras A, B . Then given a left B , right A bimodule ${}_B P_A$ we get a functor

$$P \otimes_A ? : \text{Mod}(A) \longrightarrow \text{Mod}(B)$$

and similarly a $A \otimes B^{\circ}$ module Q gives a functor the other way. Thus to get an equivalence of these module categories we need compatible isomorphisms

$$Q \otimes_B P = A \quad P \otimes_A Q = B.$$

Once these hold we get an equivalence of ~~the~~ the right module categories and also the bimodule categories:

$$X \mapsto X \otimes_B P \quad M \mapsto P \otimes_A M \otimes_A Q$$

I guess by general nonsense it follows that P is f.g. projective over B and over A° , etc.

Natural problem: Characterize the functor

~~the~~ $M \mapsto M \otimes_A$ from bimodules to vector spaces intrinsically in categorically

terms.

We can do $H^{\circ}(A, M) = \{m \mid am = ma \quad \forall a \in A\}$ as follows:

$$H^{\circ}(A, M) = \text{Hom}_{A \otimes A^{\circ}}(A, M)$$

and we can identify bimodules ~~the~~ with certain endofunctors of $\text{Mod}(A)$. Thus an element of $H^{\circ}(A, M)$ should be a natural transf. from the identity functor $X \mapsto A \otimes_A X$ to the functor $X \mapsto M \otimes_A X$.

The real question seems to be why can $M \otimes_A$ be the "fixpoints" of the functor $M \otimes_A$? Residues, duality, Lefschetz. It seems to be a good idea to review these. The reason is an analogy: If M is an R -bimodule then $M \otimes_R M = M/[R, M]$ is some sort of fixed point space. In the algebraic geometry situation, it is the restriction of M to the diagonal in the sense of quasi-coherent sheaves. Moreover the Cartier approach to residue which I would love to reconstruct uses a wrong-way map which I find reminiscent  of $M \otimes_R M$.

~~Example~~ Example: Let A/k be smooth of dim n . Then there is a canonical residue isomorphism

$$\text{Ext}_A^n(M, \Omega_{A/k}^n) = \text{Hom}_k(M, k)$$

for M a A -module finite-dim over k . The problem is to construct this isomorphism. For example if $M = A/I$ where I is generated by a regular sequence we want a canonical map

$$\text{Ext}_A^n(A/I, \Omega_{A/k}^n) = \text{Hom}_k(A/I, k) \xrightarrow{\text{eval on } 1} k$$

$$\parallel$$

$$\Lambda^n(I/I^2)^\vee \otimes_{A/I} (\Omega_{A/k}^n \otimes_{A/I} A/I)$$

However the cotangent complex theory gives a complex

So it seems worthwhile to discuss the whole Lefschetz framework. Really I should

say duality, because even over Riemann surfaces one needs the duality ~~given~~ given by the residues.

Where does one start? Duality (meaning Serre duality essentially) says that the dual of cohomology is cohomology of a dual sheaf.

~~Q~~ In Grothendieck's form

$$\mathrm{Hom}_Y(f_! F, G) = \mathrm{Hom}_X(F, f^! G)$$

where I have left out the derived functors. But more is involved:

To gain insight we ought to look at DR cohomology and take a completely concrete viewpoint.

Let M be a ~~compact~~ smooth manifold of dimension n and $\Omega^\bullet(M)$ its DR complex. Suppose M compact. Then one uses the basic pairing $C^\infty(M, E) \times C^\infty(M, E^\vee \otimes \omega) \longrightarrow C^\infty(M, \omega) \xrightarrow{\int} \mathbb{C}$ where ω is the line bundle whose sections are smooth ~~measures~~ ^{densities} on M . Thus ω is $\Lambda^n T^*$ twisted by the orientation line bundle.

It seems then that to understand DR duality we must use this pairing, or really, we must use ^{the} integration of n -forms twisted by the orientation bundle. Maybe one can obtain this directly by looking at $\Delta: M \rightarrow M \times M$ and setting up the Thom isomorphism. Thus one looks at the forms on $M \times M$ supported in a tubular nbd of the diagonal and one uses integration, Mayer-Vietoris to see this complex has the same cohomology as the twisted forms on M .

Does duality follow? Assume M oriented to simplify. One needs the Kunneth formula

$$H^*(M \times M) = H^*(M) \otimes H^*(M)$$

which follows by a Mayer-Vietoris argument. Then one takes the Kunneth components of the Thom class as in Bott's lectures, to prove Poincaré duality. Recall how this goes. One writes

$$\Delta_* 1 = \sum \alpha_i \otimes \beta_i$$

and uses

What I ~~probably~~ probably have to do is to learn the proof of the Atiyah-Bott-Lefschetz formula. One supposes given a complex of vector bundles and differential operators over a compact manifold which is elliptic. Case of a Riemann surface M . Let E be a holomorphic vector bundle on M . One has complexes

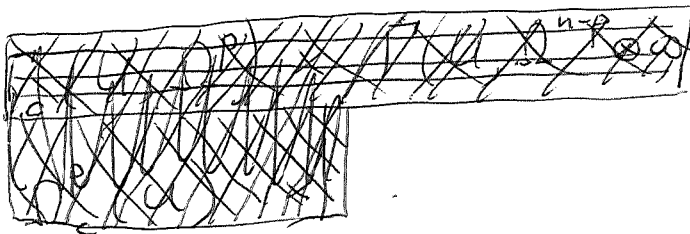

pairing together. This gives rise to Serre duality.

To be more precise we have that the dual of the Dolbeault complex of E is the distributional Dolbeault complex of $E^\vee \otimes T^{1,0} = E^\vee \otimes K$. The latter is homotopy equivalent to the Dolbeault complex of $E^\vee \otimes K$ by ellipticity. Finally use the exactness of the "dual space" functor when the complexes ~~are~~ are "split".

This raises the question of how to prove Poincaré duality for DR cohomology. I think the usual proof starts with a pairing, which is ~~shown~~ shown to be a duality first locally, then by Mayer-Vietoris. So what's the pairing?

 $= \tilde{\Gamma}(U, \Lambda^p T^* \otimes \omega)$; this is a complex of sheaves.
 By local calculations it is a resolution of ω ,
 so the global sections gives $H^*(M, \omega)$, etc.

so far I have reviewed various ideas in Poincare duality, however I really want to get some ideas about the Riemann surface case. Here one looks at the $\bar{\partial}$ complex and one doesn't have partitions of unity

It seems that a sheaf theory treatment of Poincare duality doesn't use the product manifold $M \times M$. I think the product viewpoint is very important. It's probably better for me to view Poincare duality as a consequence of Kunneth and the Thom isomorphism in the way I learned from Bott.

Recall the steps: The Thom isomorphism gives

$$\Delta_* 1 \in H^n(M \times M, M \times M - \Delta M).$$

One verifies that

$$\alpha = pr_1^* (\Delta_* 1 \cdot pr_2^* \alpha)$$

(This uses integration over M . It would be nice if one obtained integration over M at the same time one proves the Thom isomorphism; the idea is that the integration ~~is~~ is done locally using knowledge about balls.)

Suppose I don't know anything about integration of differential forms. I say that I ~~discovered~~ discovered the DR complex in studying the cyclic homology of $C^\infty(M)$. Then how might I go about constructing integration over the manifold?

You need some sort of integration to prove the Poincaré lemma. This involves integration over the unit interval. But let's suppose we have the Poincaré lemma, or more generally the homotopy axiom for DR cohomology. This gives the DR cohomology of \mathbb{R}^n .

What about the DR cohomology with compact supports on \mathbb{R}^n ? Take $n=1$. ~~is injective~~ is injective. Then $d: \Gamma_c(\mathbb{R}, \Lambda^0 T^*) \rightarrow \Gamma_c(\mathbb{R}, \Lambda^1 T^*)$ is injective. Given a 1-form $g(x)dx$ with compact support, one can integrate it $\int_{-\infty}^x g(x)dx$ using our integration in dimension 1. We obtain a smooth function $f(x) = \int_{-\infty}^x g(x)dx$ with $df = gdx$, which has compact support iff $\int_{-\infty}^{\infty} gdx = 0$. Thus the F.T.C. computes the DR cohomology. We find $H_c^1(\mathbb{R}) = \mathbb{C}$ but the isomorphism depends on the orientation of \mathbb{R} .

If we assume Künneth theorems hold for products of manifolds, then we get the calculation of $H_c^*(\mathbb{R}^n)$. The next step might be to see if we ~~have diffeomorphism~~ have diffeomorphism invariance of the isomorphism $H_c^n(\mathbb{R}^n) \xrightarrow{\sim} \mathbb{C}$.

What I am trying to do is to ~~understand~~ understand the foundations of DR theory. Let us next look at the Thom isomorphism. We have an oriented vector bundle E/M and we

want to compare the the DR cohomology of M with the DR cohomology of E with proper supports over M . Locally E is a trivial bundle, ~~and~~ and if we use the Kunneth formula, then we can see that for small open $U \subset M$, we have

$$H_{\text{proper}/U}^g(E_U) \cong \begin{cases} 0 & g \neq n = \text{rank } E \\ \mathbb{Q} & g = n \end{cases}$$

At the moment we just know that $H_{\text{proper}/U}^n(E_U)$ is 1-dim, but we have no canonical isomorphism. But this is necessary if I want obtain a global Thom class in $H_{\text{proper}/M}^n(E)$.

In fact I really ought to see what is involved in the construction of the Thom class. Thus I need to construct in each $H_{\text{proper}/U}^n(E/U)$ with U small a Thom class. Thus you would have to specify the Thom class as the unique class such that when restricted to a fibre and integrated with respect to an ^{admissibly} coordinate system on the fibre gives 1. You check via homotopy considerations that admissible refers only to the orientation. ~~That~~

~~That~~ Actually you want an integration over the fibre map for vector bundles. What does this require? ~~That~~ One can define it by trivializing the vector bundle, using Kunneth, but one has to check independence of the trivialization.

Thus it appears that there is some work involved in defining integration over the fibre

for differential forms. The kind of work involved has something to do with diffeomorphism invariance of the integral of top-dim forms.

Another possibility would be that the integral over the fibre can be defined by global duality. This means for $f: X \rightarrow Y$, that

$$\int_Y f_* (\alpha) \beta = \int_X \alpha f^*(\beta)$$

which says that the transpose of $f^*: \Omega(Y) \rightarrow \Omega(X)$ induces $f_*: \Omega(X) \rightarrow \Omega(Y)$. The smoothness of f implies that $(f_*)^t$ on currents induces f_* on forms.

I am also interested in whether knowing π_* for vector bundles might give it for manifolds. If I know the explicit integration for the normal bundle for $\Delta: M \rightarrow M \times M$, does this tell me about \int_M ?

It seems reasonable to inquire whether there is a good way to define the integral of 1-forms on the circle. I really don't know if this is a reasonable question. Look at it this way. Differential forms are defined by functions on $M \times M$ which vanish on ΔM . What makes it possible to assign a number to these?

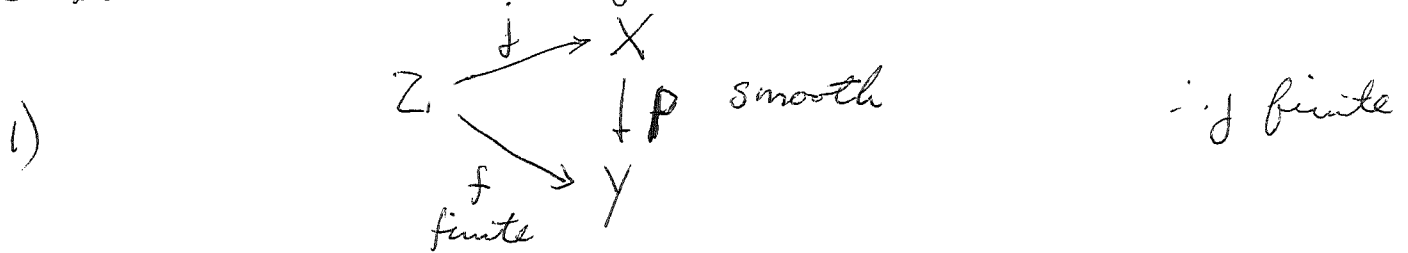

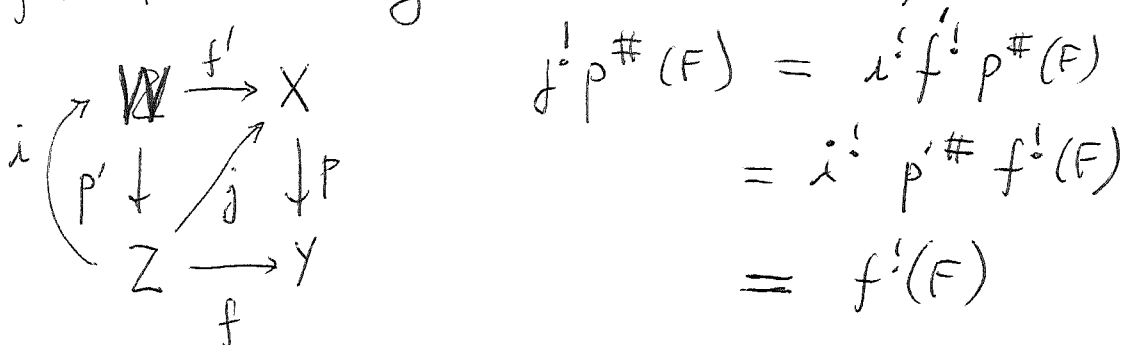

I think this justifies my feeling that the Grothendieck residue symbol can be reduced to these commutator type calculations. More work is necessary to have a complete picture.

Let's go back to the non-commutative situation, where we have the isomorphism

$$\text{Ext}'_A(M, N) = H^1(A, \text{Hom}_k(M, N))$$

We consider A non-commutative and suppose we have a resolution of left A -modules

$$\cdots \rightarrow E_{n+1} \rightarrow E_n \rightarrow \cdots \rightarrow E_1 \rightarrow E_0 \rightarrow M \rightarrow 0$$

and also a map $E_n \xrightarrow{\cong} E_{n+1} \rightarrow N$. By Yoneda we have an element of

$$\text{Ext}_A^n(M, N) = H^n\{\text{Hom}_A(B^n(A) \otimes_A M, N)\}$$

I claim we can ~~represent~~ represent this class by a map $B^n(A) \otimes_A M \rightarrow N[n]$ in a fairly concrete way. This is because $B^n(A) \otimes_A M$ has a universal property among resolutions of M , namely it comes with a contracting homotopy s , which is k -linear, given by

$$s(a_0, a_1, \dots, a_n, m) = (1, \bar{a}_0, q_1, \dots, a_n, m)$$

and s satisfies $s^2 = 0$.

(In fact it seems that the same thing is true for $B(A) \otimes_A M$ except that the condition $s^2 = 0$ is absent.)

Let's choose a contracting homotopy h of the above resolution complex such that $h^2 = 0$. Then we claim there is a unique morphism of A -module complexes which is compatible with the homotopies

$$\begin{array}{ccccccc} \xrightarrow{s} & A \otimes \bar{A} \otimes M & \xleftarrow{s} & A \otimes M & \xleftarrow{s} & M & \rightarrow 0 \\ \downarrow f_1 & & \downarrow f_0 & & \downarrow & & \\ \xrightarrow{h} & E_1 & \xrightarrow{h} & E_0 & \xrightarrow{h} & M & \rightarrow 0 \end{array}$$

In effect

$$B^N(A)_{n+1} \otimes_A M = A \otimes \bar{A}^{\otimes n+1} \otimes M$$

is the free A -module generated by the vector space $B^N(A)_n \otimes_A M / s B^N(A)_{n-1} \otimes_A M$.

So having defined f_n, f_{n-1} we define f_{n+1} to be the unique A -module map such that

$$f_{n+1} s = h f_n$$

We must check that f_{n+1} is well defined, i.e. that $h f_n s = 0$. But $h f_n s = h h f_{n-1} = 0$.

Next we must see that $\{f_n\}$ is a morphism of complexes. But

so it works.

A nice thing to do is to note that we have

Thus one has replaced the commas by s . Then the formula for the differential

Beilinson + Schechtman - Determinant bundles and Virasoro algebras.

Motivation: Let $\pi: X \rightarrow S$ be a family of Riemann surfaces ~~and~~ and let E be a vector bundle on X , everything being supposed holomorphic (or algebraic). Then one has a canonical line bundle on S

$$\lambda_E = \det(R\pi_*(E))$$

called the determinant line bundle of E . The idea will be to study this line bundle infinitesimally using an appropriate formalism which goes back to the way Atiyah constructed characteristic classes for vector bundles in alg. geometry.

Let E be a vector bundle over X (= any variety which is smooth). Let A_E be the sheaf of ^{those} differential operators $\partial: E \rightarrow E$ of order ≤ 1 whose symbol is given by a vector field times id_E . Thus $\sigma(\partial, \xi) = \langle \nu | \xi \rangle \text{id}_E$, $\nu \in \mathcal{T}_X =$ tangent bundle. Then we have an exact sequence of Lie algebras.

$$1) \quad 0 \rightarrow \text{End}(E) \rightarrow A_E \rightarrow \mathcal{T}_X \rightarrow 0$$

~~is an~~ A section of A_E is an infinitesimal automorphism of (M, E)

The extension 1) is also an extension of left \mathcal{O}_X -modules (and also right \mathcal{O}_X -modules).

(Thus ~~is~~ its an exact sequence of vector bundles). The exact sequence 1) determines

an element in

$$H^1\{\text{Hom}_{\mathcal{O}_X}(\mathcal{T}_X, \text{End}(E))\} = H^1(X, \Omega_X^1 \otimes_{\mathcal{O}_X} \text{End}(E))$$

which is the obstruction to the existence of a connection on E . Atiyah use this class to define characteristic classes for vector bundles with values in Hodge cohomology $H^p(X, \Omega^p)$.

When a splitting of 1) exists, i.e. a connection exists, then one obtains a curvature in $\Omega_X^2 \otimes_{\mathcal{O}_X} \text{End}(E)$.

I guess we can think of the exact sequence 1) together with its various structure as being a kind of infinitesimal version of E .

The first theorem calculates the extension A_{λ_E} , which because λ_E is a line bundle, is of the form

$$0 \longrightarrow \mathcal{O}_S \longrightarrow A_{\lambda_E} \longrightarrow \mathcal{T}_S \longrightarrow 0$$

Preliminaries: $\pi: X \rightarrow S$ family of curves

One has the exact sequences

Notice that $\Omega_{X/S}^\bullet$ is quasi $\pi^{-1}\mathcal{O}_S$ and \mathcal{T}_π° is quasi to $\pi^{-1}\mathcal{T}_S$. The following is then similar in spirit to the extension

Def. A π -algebra \mathcal{A}^\bullet is a sheaf of Lie algebras on X with $\pi^{-1}\mathcal{O}_S$ -module structure together with a 3 step filtration

$$0 = \mathcal{A}_{-3}^\bullet \subset \mathcal{A}_{-2}^\bullet \subset \mathcal{A}_{-1}^\bullet \subset \mathcal{A}_0^\bullet = \mathcal{A}^\bullet$$

$\underbrace{\mathcal{A}_{-3}^\bullet \subset \mathcal{A}_{-2}^\bullet}_{\cong \Omega_{X/S}[2]} \quad \underbrace{\mathcal{A}_{-2}^\bullet \subset \mathcal{A}_{-1}^\bullet}_{\text{acyclic}} \quad \underbrace{\mathcal{A}_{-1}^\bullet \subset \mathcal{A}_0^\bullet}_{\cong \mathcal{T}_\pi^\circ}$

satisfying various compatibility conditions on the Lie, filtration, \mathcal{O}_S -module structures.

Given a π -algebra \mathcal{A}^\bullet we can apply the functor $R^0\pi_* = H^0 \circ R\pi_*$ where π is proper to get an exact sequence

$$0 \rightarrow \mathcal{O}_S \rightarrow R^0\pi_*(\mathcal{A}^\bullet) \rightarrow \mathcal{T}_S \rightarrow 0$$

So the program is now to take the Atiyah extension \mathcal{A}_E and refine it to a π -algebra, ~~in fact to an acyclic~~ ~~acyclic~~. Recall we have sheaves of Lie algebras and \mathcal{O}_X -bimodules

$$0 \rightarrow \text{End}(E) \rightarrow \mathcal{A}_E \xrightarrow{\epsilon} \mathcal{T}_X \rightarrow 0$$

on X . Set

$$\mathcal{A}_{E,\pi} = \epsilon^{-1}(\mathcal{T}_\pi)$$

$$\mathcal{A}_{E/S} = \epsilon^{-1}(\mathcal{T}_{X/S})$$

whence we have a DG Lie alg. \mathcal{A}_π^\bullet

$$\mathcal{A}_{E/S} \longrightarrow \mathcal{A}_{E,\pi}$$

with an ~~acyclic~~ augmentation $\mathcal{A}_{E,\pi}^\bullet \rightarrow \mathcal{T}_\pi^\bullet$ which is surjective with the acyclic kernel $\text{Cone}(\text{id}_{\text{End}(E)})$.

Now we define an extension of $\mathcal{A}_{E,\pi}^\bullet$ by $\Omega_{X/S}^\bullet[2]$ called the trace Ω -extension of \mathcal{A}_E and denoted ${}^{\text{tr}}\mathcal{A}_E^\bullet$.

$$0 \rightarrow \omega \rightarrow \left({}^{\text{tr}}\mathcal{A}_E^\bullet \right)^{-1} \rightarrow \mathcal{A}_{E/S} \rightarrow 0$$

where the middle is defined subtly as a subquotient of jets $E \boxtimes E^\circ(2\Delta) / E \boxtimes E^\circ(-\Delta)$, $E^\circ = E^* \otimes \omega$.

The problem for me is now to understand this construction. It turns out to be interesting already in the case where $S = \text{pt}$, and it gives the Toledo - Tong proof of the 1-dimensional R-R. thm.

When $S = \text{pt}$ we have

The Virasoro algebra of E is a central extension of the Lie algebra \mathcal{A}_E by $\mathcal{H} = \omega/d\mathcal{O}$, where one works in the Zariski topology. This means that an open set U is of the form $U = X - \{x_1, \dots, x_n\}$

We have the exact sequence of Zariski

$$\text{sheaves} \quad 0 \longrightarrow \mathbb{C} \longrightarrow \mathcal{O}_X \xrightarrow{d} \omega \longrightarrow \mathcal{H} \longrightarrow 0$$

i.e. a triangle

$$\mathbb{C} \longrightarrow (\mathcal{O}_X \rightarrow \omega) \longrightarrow \mathcal{H}[-1] \longrightarrow 0$$

This gives

 \end{array}$$

since a constant sheaf is flack in the Zariski top. Here $U=X$. By Grothendieck's thm. $H^1_{DR}(U)$ is the usual $H^1(U, \mathbb{C})$, so that we have an exact sequence

$$0 \longrightarrow H^1_{DR}(X) \longrightarrow H^1_{DR}(U) \xrightarrow{(\text{res}_{x_i})} \mathbb{C}^n \xrightarrow{\Sigma} \mathbb{C} \longrightarrow 0$$

To get further we have to bring in parameters.

Let's try to reconstruct Toledo-Tung's proof of Riemann-Roch over a curve. What are the operators on $H^*(X, E)$? By ~~the~~ Kunneth and Serre duality (for an n -diml proj. variety)

$$H^*(X \times X, E \boxtimes E^* \otimes \omega[\bullet]) = H^*(X, E) \otimes \underbrace{H^*(X, E^* \otimes \omega[n])}_{H^*(X, E)^*}$$

Then $\boxed{\text{End}(H^*(X, E)) = H^n(X \times X, E \boxtimes (E^* \otimes \omega))}$

Now $H^n_{\Delta}(X \times X, E \boxtimes (E^* \otimes \omega)) = \text{Diff}(E)$. To see this one uses the local cohomology theory:

$$H^n_{\Delta}(X \times X, E \boxtimes (E^* \otimes \omega)) = H^0(X, \mathcal{H}^n_{\Delta}(X \times X, E \boxtimes (E^* \otimes \omega)))$$

and a further result

$$\mathcal{H}^n_{\Delta}(X \times X, E \boxtimes (E^* \otimes \omega)) = \varinjlim_i \text{Ext}^n_{\mathcal{O}_{X \times X}}(\mathcal{O}_{X \times X} / \mathcal{I}_{\Delta}^i, E \boxtimes (E^* \otimes \omega))$$

+ further calculations.

Let's go back to curves. Then the sheaf of differential operators on E is

$$D_E = \mathcal{H}'_\Delta(X \times X, E \boxtimes E^\circ) \quad E^\circ = E^* \otimes_{\mathcal{O}_X} \omega$$

$$= \lim_i \text{Ext}'_{\mathcal{O}_{X \times X}}(\mathcal{O}_{X \times X}(-i\Delta), E \boxtimes E^\circ)$$

$$= \lim_i \mathcal{O}_{X \times X}(i\Delta) \otimes_{\mathcal{O}_{X \times X}} E \boxtimes E^\circ / E \boxtimes E^\circ$$

$$= E \otimes_{\mathcal{O}_X} (\mathcal{O}_X \boxtimes \omega)(\infty\Delta) \otimes_{\mathcal{O}_X} E^* / E \boxtimes E^\circ$$

In the curve case Δ is a divisor in $X \times X$, so it's natural to consider all of the line bundles

$$P_E = E \otimes_{\mathcal{O}_X} (\mathcal{O}_X \boxtimes \omega)(\infty\Delta) \otimes_{\mathcal{O}_X} E^*$$

$\mathcal{O}_{X \times X}(n\Delta)$ and this leads to formal ψ DO's.

So in the same way that the ~~sheaf~~ sheaf of differential operators on the trivial bundle is

It seems that there are problems with identifying P with formal pseudo-differential operators in dimension 1 as I have been accustomed. Thus there is apparently no

non-commutative residue defined on \mathcal{P} . \mathcal{P} consists of certain kernels

$$\frac{f(t_1, t_2)}{(t_1 - t_2)^N} dt_2$$

and the log type singularity that occurs with ~~the~~ ψ DO's on the line, and which the non-commutative residue detects, is missing.

In any case we do ~~not~~ have well-defined trace on \mathcal{P}_{-1} , namely the map

$$\mathcal{P}_{-1} \rightarrow \mathcal{P}_{-1}/\mathcal{P}_{-2} = \mathcal{O}_X \otimes \omega \otimes \mathcal{O}(-\Delta) = \omega$$

To describe the Virasoro algebra $\hat{\mathcal{A}}_E$ of (X, E) where X is a curve and E is a vector bundle on it. It is a central extension of the Atiyah algebra

$$0 \rightarrow \omega/d\mathcal{O} \rightarrow \hat{\mathcal{A}}_E \rightarrow \mathcal{A}_E \rightarrow 0$$

which comes from a central extension of Lie algebras

$$0 \rightarrow \omega/d\mathcal{O} \rightarrow \hat{\mathcal{D}}_E \rightarrow \mathcal{D}_E \rightarrow 0$$

There's some mystery here with the sheaf $\omega/d\mathcal{O}$. What in fact happens is that we have ~~some~~ exact sequences

$$\begin{array}{ccccccc} 0 & \rightarrow & \mathcal{P}_{E,-1}/\mathcal{P}_{E,-2} & \rightarrow & \mathcal{P}_E/\mathcal{P}_{E,-2} & \rightarrow & \mathcal{P}_E/\mathcal{P}_{E,-1} \rightarrow 0 \\ & & \downarrow \text{"E} \otimes \text{E}^* \otimes \omega \text{"} & & \downarrow \text{"\sim\text{"} & & \parallel \\ 0 & \rightarrow & \omega & \rightarrow & \mathcal{D}_E & \rightarrow & \mathcal{D}_E \rightarrow 0 \end{array}$$

but one doesn't get a well-defined bracket on \tilde{D}_E until one divides out by differentials of functions. In the algebraic case one doesn't lose anything, see p. 558.

Further structure on \mathcal{P} - it's a bimodule over \mathcal{O}_X with formulas one expects for the way kernels compose, so that

$$\begin{aligned} (A(t)\partial_t + B(t)) \cdot \psi(t_1, t_2) dt_2 &= (A(t_1)\partial_{t_1} + B(t_1))\psi(t_1, t_2) dt_2 \\ \psi(t_1, t_2) dt_2 \cdot (A(t)\partial_t + B(t)) & \\ &= [\psi(t_1, t_2)B(t_2) - \partial_{t_2}(\psi(t_1, t_2)A(t_2))] dt_2 \end{aligned}$$

Now I ought to be able to compute the bracket in the Virasoro algebra $\hat{A}(\mathcal{O}_X)$. Take two elements - each element is a triple

$$(X, B, \nu) \iff \left(\frac{X(t_1)}{(t_2-t_1)^2} + \frac{B(t_1)}{(t_2-t_1)} + \nu \right) dt_2$$

The bracket is arranged so that

i.e. ~~the bracket~~ $ad(a)$ is ad of the differential operator associated to $a \in \mathcal{P}$.

Take two elements (X_i, B_i, ν_i) $i=1, 2$ as above

$$(X_1(t_1)\partial_{t_1} + B_1(t_1)) \left(\frac{X_2(t_1)}{(t_2-t_1)^2} + \frac{B_2(t_1)}{t_2-t_1} + \nu_2(t_1) \right) dt_2$$




This calculation seems pointless at the present time. A more interesting question is why is \mathcal{P} a D_{-1} -module?

Is it possible to define a composition on \mathcal{P} , motivated by composition of operators? Maybe a better question would be whether there is an algebra of formal Ψ DO's on a Riemann surface, and if so what is the relation of \mathcal{P} to it?

\mathcal{P} is to be thought of as a sheaf of parametrices, probably that's what the letter means.

Let's consider formal Ψ DO's on a Riemann surface. In terms of a local coordinate t these would appear as formal series

$$\sum_{n=-N}^{\infty} a_n(t) \partial_t^{-n}$$

There's a composition law which is a suitable generalization of Leibniz's formula. 

Another way to describe this algebra on X is to ~~use~~ use the sheaf of ^{formal} micro-differential operators $\hat{\mathcal{E}}_X$ on T^*X . (see book of Schapira). We consider $\mathcal{E}_X(p)$ = sheaf of homogeneous functions on T^*X of degree p , and then use the Leibniz business to define a product on

$$\hat{\mathcal{E}}_X = \bigcup_{n \in \mathbb{Z}} \Pi^{\#} \mathcal{E}_X(p)$$

Then we restrict to $T^*X - X$ and apply Π_* where $\Pi: T^*X - X \rightarrow X$. This gives an interesting algebra when $\dim(X) = 1$.

In any case it seems clear that we have nice sheaf of formal ψ DO's on a Riemann surface (and perhaps something more if one takes advantage of "analytic convergence arguments" one uses to prove Cauchy-Kowalewski). Now the question is what's the relation between these formal ψ DO's and \mathcal{P} .

Recall that \mathcal{P} consists of kernels

$$\left(\dots + \frac{a_n(x)}{(y-x)^{n+1}} + a_0(x) + a_1(x)(y-x) + \dots \right) dy$$

where $\frac{a(x)}{(y-x)^{n+1}}$ acts as

$$\operatorname{res}_{y=x} \left\{ \frac{a(x)}{(y-x)^{n+1}} f(y) dy \right\} = \frac{1}{n!} a(x) \partial_x^n f(x)$$

Let's try putting in a log term formula


$$\begin{aligned} & \operatorname{res}_{y=x} \left\{ a(x) \log(y-x) f(y) dy \right\} \\ &= \operatorname{res}_{y=x} \left\{ \frac{a(x)}{y-x} \left(\int^y f \right) dy \right\} = - \int^x f = -\partial_x^{-1} f \end{aligned}$$

Therefore formally it appears that the ~~space~~ space \mathcal{P} maps to the algebra of formal ψ DO's, and the image is the differential operators.

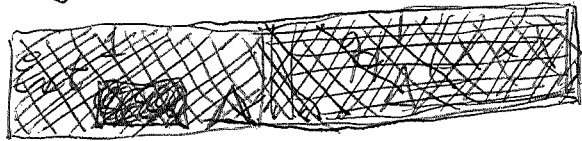

Let's discuss the RR theorem on a ^{complete n.s.} curve X from the viewpoint of duality and intersections. Ultimately ~~I~~ want to look at the Toledo-Tong paper. 

Let start with a differential operator $\mathcal{D}: E \rightarrow E$, for example the identity. This induces a map on cohomology $H^*(X, E)$ and we want to calculate the traces. Grothendieck's theory gives us the following way to proceed.

First of all there is the identification of the sheaf of differential operators \mathcal{D}_E with local homology sheaves

Next the passage from local to global

$$= \text{End}^0(H^*(X, E)).$$

Combining these gives a map $\mathcal{D}_E(X) \rightarrow \text{End}^0(H^*(X, E))$ which has to be the induced map of a diff op.

on cohomology.

On the other hand we have the map

$$5) \quad H^1(X \times X, E \boxtimes E^0) \xrightarrow{\Delta^*} H^1(X, \text{End}(E) \otimes \omega)$$

$$\xrightarrow{\text{Tr}} H^1(X, \omega) \xrightarrow{\int} \mathbb{C}$$

which gives the trace of an elt. of $\text{End}^0(H^1(X, E))$. This part is obvious from the nature of Kunneth and Serre duality.

Let M be an A -module which is finite-dimensional over k . Then we have constructed maps

$$1) \quad \text{Ext}_A^n(M, M) \longrightarrow \text{Hom}(H_n(A, A), k)$$

using the trace on $\text{End}(M)$. (These maps were used by Cartier to construct the Grothendieck residue symbol, I believe.)

I would like to generalize the construction to the case where M is finite projective over an algebra B . Thus I want M to be an $A \otimes B^0$ -module which is finite projective over B . Then we have a map

$$A \longrightarrow \text{End}_{B^0}(M) \xrightarrow{\text{tr}_M} B/[B, B]$$

which vanishes on $[A, A]$, hence induces a bilinear map

$$A/[A, A] \longrightarrow B/[B, B]$$

But the generalization of 1) for $n=0$ is the map

$$\text{Hom}_{A \otimes B^0}(M, M) \longrightarrow \text{Hom}(A/[A, A], B/[B, B])$$

$$\text{Hom}_{B^0}(M, M)^A$$

which sends $f \longmapsto (a \longmapsto \text{tr}_M(af))$

Let's next consider the case $n=1$. Start with an $A \otimes B^0$ -module extension:

Since M is B° -projective, we can choose a B° -linear splitting h . Set

Then φ is a derivation of A with values in $\text{End}_{B^\circ}(M)$ considered as an A -bimodule in the obvious way. Changing $h \rightarrow h + iu$ where $u \in \text{End}_{B^\circ}(M)$, changes $\varphi(a)$ to ~~$\varphi(a)$~~

$$i^{-1}[a, h + iu] = \underbrace{i^{-1}[a, h]}_{\varphi(a)} + \underbrace{i^{-1}[a, iu]}_{[a, u] = (\delta u)(a)}.$$

Thus we get well-defined maps

$$\text{Ext}'_{A \otimes B^\circ}(M, N) \longrightarrow H^1(A, \text{Hom}_{B^\circ}(M, N))$$

when M is B° -projective. This map is an isomorphism, because $B^N(A) \otimes_A M$ is a projective $A \otimes B^\circ$ -module resolution of M . Thus we have more generally

$$\begin{aligned} \text{Ext}^n_{A \otimes B^\circ}(M, N) &= H^n \left\{ \text{Hom}_{A \otimes B^\circ}(B^N(A) \otimes_A M, N) \right\} \\ &= H^n \left\{ \text{Hom}_{A \otimes A^\circ}(B^N(A), \text{Hom}_{B^\circ}(M, N)) \right\} \\ &= H^n(A, \text{Hom}_{B^\circ}(M, N)) \end{aligned}$$

Next suppose M finitely generated as well as projective over B° . Then we have the trace map

Let's get the map straight in the case where $E = \mathcal{O}_X$, $F = \omega$ so that we want to associate to principal part of merom. function along Δ as differential operator $\partial: \omega \rightarrow \mathcal{O}_X$. So we want a map

$$\mathcal{O}_{X \times X}(\infty\Delta) / \mathcal{O}_{X \times X} \longrightarrow \text{Diff}(\omega, \mathcal{O}_X)$$

This map will be given by sending $\frac{f(x,y)}{(y-x)^n}$ and $g(y)dy$ to $\text{Res}_{y=x} \left(\frac{f(x,y)g(y)dy}{(y-x)^n} \right)$.

To define the residue we proceed as follows. First we identify

$$\mathcal{O}_{X \times X}(n\Delta) / \mathcal{O}_{X \times X} = \text{Ext}_{\mathcal{O}_{X \times X}}^1 \left(\mathcal{O}_{X \times X} / \mathcal{O}_{X \times X}(-n\Delta), \mathcal{O}_{X \times X} \right)$$

We have the canonical extension

and there's a map $\downarrow \cong$ induced by $\xi \in \mathcal{O}_{X \times X}(n\Delta) / \mathcal{O}_{X \times X}$.

Choose the splitting h to be linear over $\mathcal{O}_X \otimes \mathbb{C}$.

Then for any $g \in \mathcal{O}_{X \times X}$, we consider the

operator $\xi[g, h]$ on $\mathcal{O}_{X \times X} / \mathcal{O}_{X \times X}(-n\Delta)$

and we take its trace over $\mathcal{O}_X \otimes \mathbb{C}$. This

trace is the $\text{Res}_{y=x} \left(\xi \frac{dg}{g} \right)$. Note that it

depends on $dg \in \mathcal{I}'_{X \times X / X \times pt} = \mathcal{O}_X \boxtimes \omega$

This is all a bit confusing and it's not immediately clear how to link it with the situation on p 568. This is the problem with Cartier's procedure, which perhaps improves with Tate's version. My interest in Tate's version is because it gives rise to a cyclic cocycle $res(fdg)$ unlike the Hochschild cocycles obtained so far.

I have to go back to the cyclic 1-cocycle occurring for Toeplitz operators on the circle. Thus ~~we~~ suppose we have an extension

$$0 \rightarrow I \rightarrow R \xrightarrow{f} A \rightarrow 0$$

and a linear functional $\tau: I/[R, I] \rightarrow \mathbb{C}$. If we choose a linear lifting ρ , then we obtain a cyclic 1-cocycle (normalized) on A given by

$$\varphi(a_0, a_1) = \tau([\rho(a_0), \rho(a_1)] - \rho[a_0, a_1])$$

In the circle case, we have $A = C^\infty(S^1)$ acting on $L^2(S^1) = H^+ \oplus H^-$, and R is an algebra of operators on H^+ containing the Toeplitz operators $T_f = P \circ f \circ P$ where $P =$ orthogonal projection on H^+ .

The lifting ρ is then $\rho(f) = P f P$, and the cyclic cocycle is

$$\varphi(f, g) = \text{tr}_{H^+} ([P f P, P g P] - P[f, g]P) \quad \text{can be } \neq 0 \text{ for matrix functions}$$

Now
$$\begin{aligned} [P f P, P g P] &= P f P g P - P g P f P \\ &= P f (g P + [P, g]) P - P (P g - [P, g]) f P \end{aligned}$$

Thus

Let's go over the Tate method as presented by Beilinson-Schectman. $U = \text{Spec } \mathbb{C}[[t]]$. $\tilde{u} = \text{Sp}(\mathbb{C}((t)))$, E vector bundle on U , $F = E(\tilde{u}) \cong \mathbb{C}((t))^n$. $E(u) \cong \mathbb{C}[[t]]^n$. Call a \mathbb{C} -linear subspace V bounded if $V \subset t^{-N}E(u)$ some N and open if $V \supset t^N E(u)$ for some N ; lattice = bounded + open subspace. Let $R \subset \text{End}_{\mathbb{C}}(F)$ be the alg. of continuous operators ($T \in R \iff (V \text{ open} \Rightarrow T^{-1}(V) \text{ open})$), let $I_0 = \{A \in R \mid \text{Im } A \text{ bounded}\}$, $I_1 = \{A \in R \mid \text{Ker } A \text{ open}\}$. Then I_0, I_1 are ideals in R such that $I_0 + I_1 = R$. Also a trace is defined on $I_0 \cap I_1$ such that $\text{tr}(ab) = \text{tr}(ba)$ $a \in I_0, b \in I_1$.

This apparently is not what I want although it suggests an approach, namely one has an R -bimodule extension

$$0 \rightarrow I_0 \wedge I_1 \rightarrow I_0 \oplus I_1 \rightarrow R \rightarrow 0$$

and a trace on the kernel. This leads to a linear functional on $H_1(R, R)$, in fact to a cyclic 1-cocycle class, which in turn gives a central extension \hat{R} of R by \mathbb{C} . B+S show this leads to the Virasoro extension $\hat{D}_E(\hat{u})$ of $D_E(\hat{u})$ by pulling back via the embedding $D_E(\hat{u}) \subset R$.

So let's take up this idea that the residue is the linear functional on $\hat{\Omega}_A^1$ associated to an A -bimodule extension

$$0 \rightarrow K \rightarrow Q \xrightarrow{\pi} A \rightarrow 0$$

together with a trace τ on $K \otimes_A A$. Such an extension with trace ought to be easy to find. Since we want to obtain a 1-cocycle from this we want to have a bimodule map $A \otimes A^0 \rightarrow Q$ which means an element of Q .

It seems that we want to take Q to consist of operators which are linear combinations of $a_1 P a_2$ for $a_1, a_2 \in A$ and smooth kernel operators. The map π takes the symbol of this ψ DO and restricts to $\{>0\}$, so it gives $a_1 P a_2 \rightarrow a_1 a_2$.

Let's compute the cocycle by mapping $B^N(A)$ into the above resolution.

Now lots of questions arise. It seems that we have lots of extensions of A that all

give rise to the same cocycle. First of all there is the Toeplitz extension. This is an extension of algebras and it is only by manipulation that we can get from the formula $\text{tr}([p(f), p(g)] - p([f, g]))$ to the formula $\text{tr}(f[p, P])$. This transition seems to be important, and I suspect a proper understanding would link cyclic cocycles to non-commutative differential forms as Connes has done. It might be related to the Stinespring construction.

But there are also ~~two~~ ^{two} bimodule extensions ~~which~~ which lead to the same cocycle. The bimodule Q is even an algebra, but it's non-unital.

Actually there is a central extension of \mathcal{D}_E as
